# Sub Committees & 'Honorary' Positions

## RESCUE

A huge effort is put in by Ricki and the Club committee ensuring that any Rhodesian Ridgeback so unfortunate as to be without a home can be found new loving owners. Getting involved in Rescue can mean as little as running games at our Fun Day to as much as physically transporting or fostering rescue dogs and liaising to find them new homes.

## NEWSLETTER

Duties range from putting together the Rave (Editor) to assisting by collecting articles, jokes, pictures etc for the Rave, collating show results, and mailing the Ridgie Rave. Again an area where every little bit helps.

## SHOW SUB-COMMITTEE

Organises the RRCQ Inc Champ & Open Shows. The Show Secretary undertakes the paperwork required for conformation shows and ensures the smooth running of all aspects of the show. You MUST be a Dogs Queensland member to be a Show Secretary. You don't show your dogs? All the better!

## TROPHY STEWARDS

Perpetual trophy steward is the guardian of the Club's perpetual trophies and collator of results for same. The Show Trophy Steward organises sponsorship (commercial and members), trophies and sashes for the Club shows.

## FUNDRAISING-

Organises Bunnings BBQs, raffles, fundays, chocolate drives in fact any activity that they can to keep the Club financial and fund Rescue and special events such as the 11<sup>th</sup> RR National in 2014.

## MEDIA/PR

Maintain and update the RRCQ website and manage the RRCQ FaceBook pages.

## MERCHANDISING OFFICER-

Responsible for sourcing and sales of merchandise for the Club including manning the Club sales table at Club events.

## NRRC REPRESENTATIVE-

The liaison between the RRCQ Inc and the National Rhodesian Ridgeback Council, the NRRC Rep attends NRRC meetings, usually held at Championship Specialty Shows to present the views and votes of RRCQ Inc members.
